Privacy policy

Introduction

We are responsible for Your right to privacy and are committed to using the Website https://vvs-info.ru/ (hereinafter - Site) was as comfortable as possible.

This privacy Policy ("Policy") applies to information directly related to Your personality (hereinafter "Data") that may be collected on the Site and applies to personal data that the company "VVS" (hereinafter "Organization") may obtain from users when you visit this website, as well as explain how will be the processing and protection of personal data of users. Obtaining personal information
